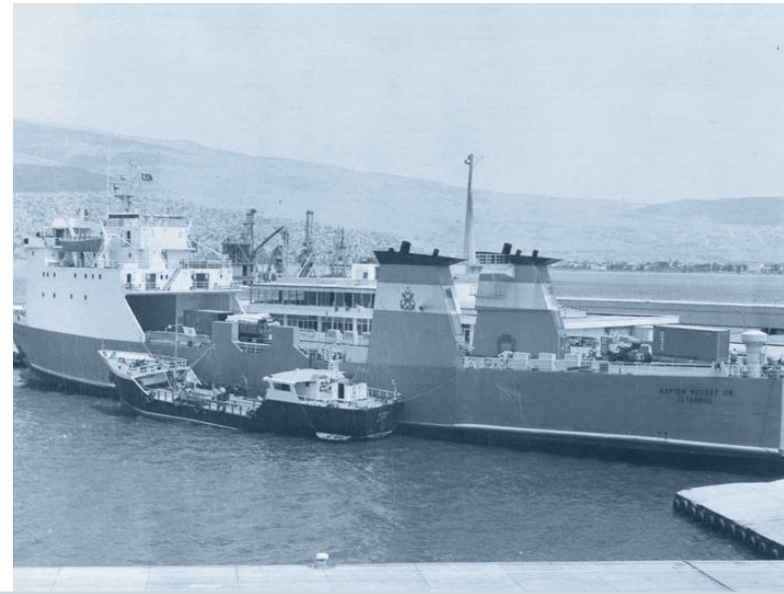

From 1977 to Today



1977

Starting with the acquisition of its first oil tanker, Asmira Group began its ship fuel supply (bunker) operations in İzmir. As a result, Asmira Group became the first company to receive the “port agent” status from Petrol Ofisi.



1982

Acquisition of second sea tanker to increase supply power.



1995

Performing smaller quantited supplies, that cannot be done through sea tankers, by enlarging the road tanker fleet.

2000

First yacht refueling.



2001

Establishment of “Asmira Petrol” subsidiary by creating a new structure in order to carry out marine fuel sales through a dedicated company.



2010

Becoming the leader in the yacht fuel market in Türkiye.



2013

Acquirement of the D-Marin Didim marina fuel station, incorporating the first marina station into operation.

2014

Within the scope of the European Agreement on the Carriage of Dangerous Goods by Road, the entire land tanker fleet was renewed with ADR top profile fuel tankers and transferred to the new subsidiary which was established under the name of “Asmira Logistics”.

2015

Becoming one of the leading companies in Türkiye that makes supply with the sample system in compliance with the Marpol Annex VI regulations.



2016

Providing competitive advantage through innovative systems and process management such as organic fight against environmental pollution, automatic bypass systems, hose sheathing system and safety strips etc.



2017

By acquiring D-Marin Turgutreis marina fuel station, making a difference in marina station operations in the region.



2018

Expansion of the naval fleet with the acquisition of the third naval tanker KINGFISHER V. Construction of a new Operations Center in Torbalı to carry out industrial sales and operation activities.

Acquisition the Montenegro Portonovi Marina fuel station to launch the first actual operations abroad.

2019

By acquiring D-Marin Göcek and Kuşadası Setur marina fuel stations, having 4 marina station operations in Turkey.



2020

Beginning of the bunker trade activities in İstanbul.

With the acquisition of Çeşme Marina Lukoil Fuel Station, the number of marine stations increased to 5.



2021

Shaking hands for the Turkish distributorship of Opet Otobil Systems and starting sales across Türkiye.

Opening of the Istanbul Skyland Trade Office physically.

2022

Increasing the number of charter fleet of Asmira Marine to 6 by investing in additional 1 monohull and 1 catamaran boats.

Opening of offices for Asmira Energy Derince and Asmira Marine Göcek.

2023

As part of the restructuring project, Asmira Group companies were organized on a global scale as Asmira Marine, Asmira Energy, Tacklog and Miraka.



2024

With the acquisition of the D-Marin Dalmacija fuel station in Zadar, Croatia, the initiation of the second overseas physical operations begins.

Adding another Bali 4.4 for the 2024 season increases the charter fleet to 7.

The opening of the second gas station in Datça Marmaris.

By starting up the fuel dock operation in Ağanlar Shipyard & Marina, the second Bodrum location is set to make a significant impact in the Gulf of Gökova.

Within the scope of the exclusivity agreement, becoming the first and only dealer of Frauscher Boats in Türkiye.



2025

Acquisition of a Bali 4.6 and a Bavaria Cruiser 46 for the 2025 season, increasing the charter fleet to 9 yachts.

Establishment of Orfeo Events under Asmira Group, focusing on corporate event management.

Investment in "Kumbor", the first and only next-generation double-hull sea tanker.

Founding of Ancre Suisse in Switzerland as part of Asmira Group's international commercial activities.

Launch of yacht brokerage operations under Asmira Marine.

Expansion of marina fuel stations to 9 with the acquisition of MarinTurk Göcek, Seferihisar Teos Marina, and Oasis Marina Yeni Foça locations.

Increase of gas stations to 4 with the acquisition of 2 new stations in Milas.

Having a total of 26 supply points with duty-paid and duty-free (Transit & Exported) products in accordance with ISO 8217:2017 and EN590 standards. With its fleet of specially equipped land and marine tankers, as well as 'Kumbor'—the first and only new-generation double-hull sea tanker—the company provides services 24/7.

By the capability of loading their highly equipped barge and road tanker fleet from 4 different terminals throughout Türkiye, Asmira can supply its customers with uninterrupted and trouble-free domestic and transit gas oil 24/7.

Carrying its boutique service approach also to barge supplies, Asmira carries out each barge supply under the control and supervision of 2 separate independent survey companies, making the service completely transparent to its customers.
